


Public Works has cleared out a lot of shoreline down by the river. They will be doing a lot of work on the beds around the building, so this spring and summer it's going to look as good.

DID YOU KNOW.....

150 years ago on the 22nd day of April, 1876, there were returns of an election held on the lawn of Hampton, voting "for or against Village organization under the General Law." The Judge of the County Court, Samuel D Guyer, called to his assistance, M.L. Pinkley and S.F. Cooke, two Justices of the Peace of said County, the following is the result of the canvass: "For the Village organization under the general law, 74 votes, against Village organization under the general law, 9 votes." Thus began the President and Board of Trustees!

The village was originally in territory claimed by the Sauk and Meskwaki Native Americans, and several Woodland era Native mounds are located in the village limits, and in the adjacent Illiniwek Forest Preserve.

The village in 1834 was platted as "Milan" (not the village 13 miles south-southwest in Illinois). The "paper town" did not sell initially because of the swampy riverfront, and being adjacent to the north end of the Rock Island Rapids. However, settlers drained the swamps by the end of the 19th century, and the village was founded as Hampton. Black's Store, which is listed on the National Register of Historic Places, was the first mercantile store to open in Northwest Illinois.
