

## 1. AUTHORIZATION REQUIREMENTS.

Application is hereby made for a Floodplain Development Permit (hereafter called permit) as required under Rock Island County Code of Ordinances, Title 3, Chapter 2, Section 38 (3-2-38) for development as defined in said ordinance. The applicant understands and agrees that:

- Permits are required for "Any man made change to real estate" in the mapped floodplain and further defined as a. Development in Section 3-2-38.1; "Development does not include routine maintenance of existing buildings and facilities, resurfacing roads, or gardening, plowing & similar practices..."
- If the proposed development is located wholly or partly within an identified Floodway of the Mississippi or Rock b. Rivers, authorization will be withheld until a permit is issued by the Illinois Department of Natural Resources/Office of Water Resources (IDNR-OWR);
- The permit applied for, if granted, is issued on the representations made herein; c.
- That any permit issued may be revoked because of any breach of representation; d.
- That once a permit is revoked, all work shall cease until the permit is reissued or a new permit is issued; e.
- The building or development site shall not be used or occupied unless an Certificate of Occupancy has been issued; f.
- The applicant hereby gives consent to the designated officials of the Rock Island County, IL, or their g. representatives, to make reasonable inspections to enforce the provisions of said Section 3-2-38 without first obtaining a search warrant; and
- If issued, the permit will expire if no work is commenced within six (6) months of issuance. h.

I,\_\_\_\_\_\_\_being a Registered Professional Engineer/Architect with the State of Illinois, do hereby state that I have reviewed the plans of the proposed development plan described in this application and I hereby certify that all sections of the proposed building located below \_\_\_\_\_\_ MSL and attendant utility facilities will be watertight and capable of resisting the effects of the base flood. The building design takes into account flood velocities, duration, rate of rise, hydrostatic and hydrodynamic forces, the effects of buoyancy, and the impacts from debris and ice.
