BE IT REMEMBERED, THAT THERE CAME AND WAS HELD AN ADMINISTRATIVE COMMITTEE MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF HAMPTON, ILLINOIS IN THE VILLAGE HALL OF SAID VILLAGE:

Trustee VanDieren called the meeting to order at 7:00 PM. Clerk Toalson called the roll noting a quorum present and the Pledge of Allegiance was recited.

Administrative Towing Fee Ordinance: Chief Engle presented a copy of a sample ordinance establishing an administrative fee for towing a vehicle when a driver is arrested for certain offenses. The fee is \$200.00 payable to the Village, in addition to any other fines or fees. Discussed. The committee recommends the ordinance to the committee of the whole for consideration at the next meeting.

Third Avenue One Way between 4<sup>th</sup> and 5<sup>th</sup> Street: Chief Engle proposed making 3<sup>rd</sup> Avenue between 4<sup>th</sup> and 5<sup>th</sup> Streets a one way going south. This is the block the school is in and traffic would flow better if it was a one way. Discussed. The committee recommends the ordinance to the committee of the whole for consideration at the next meeting.

Discussed accepting credit/debit card payments for water bills over the phone. The service charge paid to the credit card company is much higher if we do not swipe a card in the machine. (i.e. manually entering the card number and expiration date.) Discussed charging an additional fee for phone payments. This will be placed on the agenda for the next regular meeting to discuss.

Trustee Heintz told of a car that is frequently parked along Barrington Drive close to a curve that could cause an accident. Many of the Hampton Woods neighbors have expressed concerns about the vehicle parked there and causing an accident. Discussed making the corner a no parking zone. Chief Engle will check the area out with Supervisor McKay to determine a description of the no parking zone for an ordinance.

Chief Engle stated he has had a conversation with President Irby about changing the hours of operation for the Class F Liquor License to a 2 A.M. closing, now that Shannons has closed. Discussed changing the time or eliminating the Class F license. This item will be brought up at the next regular meeting to discuss.

There being no further business, the meeting was adjourned at 7:40 PM.
