President Vershaw called the meeting to order at 7:00 PM. Clerk Bergeson called the roll noting a quorum present and the Pledge of Allegiance was recited.

**Approval of the Minutes of the Regular Meeting of April 9, 2018:** Motion was made by Trustee King, second by Trustee Hamilton. Voice Vote all in favor, none opposed. Heintz, VanDieren absent. Motion carried.

**Approval of the Minutes of the Regular Meeting of April 16, 2018:** Motion was made by Trustee King, second by Trustee Goodman. Voice Vote all in favor, none opposed. Heintz, VanDieren absent. Motion carried.

**Approval and Authorization of Payment of Bills:** Motion was made by Trustee Adams second by Trustee Hamilton. Roll call vote as follows: Adams, Hamilton, Heintz, King and Goodman: "Aye." VanDieren absent. Motion carried.

**Discussion, Approval and Authorization from Azavar Government Solution:**No one appeared from Azavar. Motion made by Hamilton to move the discussion to No. 14a. on the agenda, second by Goodman. Voice Vote all in favor, none opposed. VanDieren absent. Motion carried.

**Discussion, Approval and Authorization for Utility Service Partners:** Rob Meston from Utility Partners approached the board with the warranty that Utility Service Partners provide. It is a company that will cover up to \$8,500 of damage in the event a disaster should happen. Monthly rates begin at \$5.45 for water, \$7.25 for sewer and \$9.49 for interior coverage. Motion made by King second by Adams to table the matter until Mr. Meston could answer a few of the more specific questions. Voice Vote all in favor, none opposed. VanDieren absent. Motion carried.

Approval and Authorization for the Intergovernmental Agreement with Mississippi Rapids Rest Area Security: Motion made by King second by Hamilton to table the matter until the Clerk could present a 3 year contract. Voice Vote all in favor, none opposed. VanDieren absent. Motion carried.

**Discussion regarding a new contract for the Heritage Center:** Clerk Bergeson feels that there needs to be a more specific contract at the heritage center in regards to the liability of the Village. Trustee Goodman to schedule a committee meeting.

Consideration and Approval of the quote from Advantage Auto Body Inc.:

Supervisor McKay had an accident with the Village Plow truck this winter, a quote from Advantage Auto Body was submitted for the board's review and approval. Trustee Heintz feels that we should submit this claim to insurance. Motion by King second by Hamilton to deny the quote from Advantage Auto Body. Roll call as follows: King VanDieren absent. Motion carried.

Motion made by Heintz, second by Hamilton to turn the claim into insurance. Roll call as follows: Heintz, Hamilton and Goodman: "Aye" Adams and King: "Nay" VanDieren absent. Motion carried.

Consideration and Approval of the purchase of ammunition: Motion by Hamilton, second by King to approve the purchase the purchase of ammunition in the amount of \$334.19. Roll call vote as follows: Hamilton, VanDieren absent. Motion carried.

Consideration and Approval of the replacement of annual equipment: Motion made by Trustee Hamilton, second by Trustee King, to replace the equipment, less the boots. Discussion that they Chief was just waiting until the end of the year to use the budget. Roll call as follows: Hamilton and King: "Aye" Heintz, Goodman and Adams: "Nay". VanDieren absent. Motion failed. Motion to put this on the next Agenda for discussion: Motion my Goodman second by Hamilton, Voice vote all in favor, none opposed. VanDieren absent. Motion carried.

Consideration and Approval of attending the Illinois Fire Service Institute: Motion made by Trustee Goodman second by Trustee Hamilton to table the matter until Chief Johnson could be present and answer a few of the questions. Voice vote all in favor, none opposed. VanDieren absent. Motion carried.
