Consideration and Approval of the Minutes of the Meeting of March 25, 2019: Motion by Trustee Goodman, second by Trustee Adams to approve the regular meeting minutes. Motion carried by unanimous voice vote.

Consideration and Approval of the Minutes of the Budget Meeting of April 4, 2019: Motion by Trustee Goodman, second by Trustee Adams to approve the budget meeting minutes. Motion carried by unanimous voice vote.

Approval and Authorization for Payment of Bills: Motion by Trustee Adams, second by Trustee Goodman to approve the payment of bills. Roll call vote as follows: Adams, Goodman, King and VanDieren: "Aye", Motion carried.

Consideration and Approval of the Project Graduation donation to UTHS: Motion by Trustee King second by Trustee Goodman to approve \$100.00 to Project Graduation to UTHS. Roll call vote as follows: King, Goodman, Adams and VanDieren: "Aye", Motion carried.

Discussion, Consideration and Approval of the quotes from BI-State Masonry and B&B Masonry regarding Village Hall foundation: Clerk Reyes obtained quotes for the foundation of Village Hall, with President Vershaw not available Clerk Reyes would like to wait for a full quorum to discuss the matter. Motion was made by Trustee Goodman, seconded by Trustee Adams to table the matter until the next available meeting. Motion carried by unanimous voice vote.

Consideration and Approval of sending Clerk to IRWA training in Fairview: Clerk Reyes would like to attend the IRWA annual administrative conference in Fairview, it is a informative conference regarding our water/sewer system. Motion was made by Trustee Adams, second by Trustee Goodman to approve the training, travel and lodging to the conference. Motion by Trustee Adams, second by Trustee Goodman to approve using MFT funds to move forward. Roll call vote as follows: Adams, Goodman, King and VanDieren: "Aye", Motion carried.

Discussion, Consideration and Approval of seal coating remaining alleys. In absence of Trustee Heintz, Supervisor McKay would like to move forward with contacting our engineers to begin process and the use of MFT funds for sealcoating our alleys. Motion by Trustee Adams, second by Trustee Goodman to approve using MFT funds to move forward. Roll call vote as follows: Adams, Goodman, King and VanDieren: "Aye", Motion carried.

Discussion, Consideration and Approval of charging a fee for all credit card transactions for water bills. Motion was made by Motion by Trustee Adams, second by Trustee Goodman to increase all credit card transaction fees at Village Hall to 3% to offset the bank fees. Consideration and Approval of the waiver of the fee of the rental for Breaking the Wishbone at the Heritage Center on May 15, 2019.
