President Vershaw called the meeting to order at 7:00 PM. Clerk Reyes called the roll noting a quorum present and the Pledge of Allegiance was recited. Meeting was held at the Hampton Village Hall.

Consideration and Approval of the minutes of the meeting November 25, 2019: Motion by Trustee Hamilton, second by Trustee Goodman, to approve the minutes. Motion carried by unanimous voice vote.

Approval and Authorization for Payment of Bills: Motion by Trustee VanDieren, second by Trustee Hamilton to approve the bills and authorize for payment. Motion carried by roll call vote to approve payment of bills.

Lori Rotz from the Logger House to address the Board. Bill Rotz addressed the Board wanting to know what the plan is to fix the failing infrastructure. They have been directly affected by these watermain breaks and water boil orders, they almost lost a party due to the break in parking lot. President Vershaw stated that since we repaired the altitude valve we should not the issues we experiencing. However, we are looking into having a low/medium income survey done as it is necessary to move forward in any grant or low interest loans. Bi-State is helping us with this.

Consideration and Approval of Ordinance 2019-834 An Ordinance of the Village of Hampton, Rock Island County, Illinois, Authorizing Distribution of Surplus from the Special Tax Allocation Fund of TIF Number III; Closing the Special Tax Allocation Fund of TIF Number III. Motion to approve the Ordinance by Adams, second by Trustee King. Motion carried by roll call vote.

Consideration and Approval of the utility billing software license \$2096.11. Motion to approve the software license by King, second by Trustee Hamilton. Motion carried by roll call vote.

**Discussion regarding the meeting with the Zoning Board Josh Wallace.** On December 5, 2019, the Zoning Board of Appeals held a meeting with Mr. Wallace in which they denied his request for special use due after much consideration. It is the council board who shall make the final decision. Based on the concerns of the members of the zoning committee it was in the best interest of the council board to hear those concerns prior to making a decision. Consideration and Approval of the thermostats for the Heritage Center. Motion made by Trustee Bornhoeft, second by Trustee Hamilton to rescind the Motion by roll call vote.

Consideration and Approval of the 2 quotes from Jim Whan Automotive. Motion made by Trustee King, second by Trustee Hamilton. Motion approved by roll call vote.
