President Vershaw called the meeting to order at 7:00 PM. Clerk Reyes called the roll noting a quorum present and the Pledge of Allegiance was recited. Meeting was held via ZOOM with the Village Hall open to the public for comment due to COVID-19.

Consideration and Approval of the minutes from the meeting January 25, 2021.

Motion by Trustee Adams, second by Trustee Bornhoeft to approve the minutes with changes.

Motion approved by voice vote.

Consideration and Approval of the payment of Bills. Motion by Adams, second by Bornhoeft, Motion to approve the bills by roll call as follows: Bornhoeft, King, VanDieren and Adams. Motion passed.

Acknowledgement of Visitors Who Desire to Address the Board. Bob Fields resident of Hampton also owner of Fields of Pizza, East Moline, would like to donate to the Village Public Safety. Mr. Fields would like to donate 20% of sales on a specific day once the restrictions are lifted, he begins full operation on March 1<sup>st</sup>. Mr. Fields will contact Clerk Reyes with a date that works.

Consideration and Approval of the AT&T Generator. Motion by Trustee Bornhoeft seconded by Trustee King, discussion to allow the Public Works and Police Department to tie into the generator. President Vershaw will contact AT&T to discuss. Motion rescinded with a motion by Trustee King, second by Trustee Bornhoeft to table until discussion with AT&T. Motion passed by unanimous voice vote.

**Discussion, Consideration and Approval of updating computers.** Motion by Trustee Bornhoeft second by Trustee Adams to lease 2 new desktops for the Police Department with the upgraded laptop and desktop going to the Fire Department. Roll call as follows: Bornhoeft, VanDieren and Adams: "Aye", King: "Nay". Motion passed.

Consideration and Approval of the quotes to fix the pump house. Supervisor McKay called several contractors for quotes at this time weather is a factor. No quotes were given. This is an emergency situation, the controls are getting wet from the hole in the roof. Once weather is in favor, Supervisor McKay can call for an immediate approval with the trustees. Motion to table until quotes and weather allow. Motion by Trustee King, second by Trustee Adams. Motion passed by unanimous voice vote.
