President Bornhoeft called the meeting to order at 7:00 PM. Deputy Clerk Hooker called the roll noting a quorum present and the Pledge of Allegiance was recited. Meeting was held at the Village Hall.

Consideration and Approval of the minutes from the meeting December 13, 2021. Motion by Trustee King, second by Trustee McKay. Motion approved with changes by unanimous voice vote.

Consideration and approval of payment of Bills. Trustee King addressed Supervisor Toalson regarding mirror for pickup. Motion by Trustee King, second by Trustee Gonzalez to approve the bills. Roll call as follows White, McKay, King, Schneckloth, Gonzalez: "Aye". Trustee Adams: Absent. Motion approved.

Acknowledgement of Visitors Who Desire to Address the Board. President Bornhoeft presented resident Marcus Schneckloth with a certificate of "Honorary Fire Chief" to be put in to action January 4, 2022 for resident's birthday.

Consideration and Approval of the renewal of Liquor License. Motion by Trustee King, second by Trustee Gonzalez. Motion approved by unanimous voice vote.

Consideration and Approval of the pay estimate to Valley for \$89,074.97 Motion by Trustee King, second by Trustee White. Motion approved with changes by Trustee McKay, Trustee Schneckloth, and Trustee King; Trustee Gonzalez: Nay; Trustee Adams absent.

Discussion, Consideration and Approval of change to methods of making utility bill payments. President Bornhoeft and Deputy Clerk Hooker discussed problematic issues with utility bills paid at Porters. Agreed to continue with handling utility billing with prior implemented changes and discuss at later date if any changes need to be made. Died due to lack of Motion.
