President Bornhoeft called the meeting to order at 6:30 PM. Clerk Reyes called the roll noting a quorum present and the Pledge of Allegiance was recited. Meeting was held at the Village Hall.

Consideration and Approval of the minutes from the meeting December 27, 2022. Motion by Trustee White, second by Trustee Adams. Motion approved by voice vote.

**Consideration and approval of payment of Bills.** Motion by Trustee McKay, second by Trustee Adams to approve the bills. Roll call as follows: White, McKay, Smice, Gonzalez and Adams: "Aye". Schneckloth absent. Motion approved.

Acknowledgement of Visitors Who Desire to Address the Board. No one addressed the board.

Consideration and approval of the Intergovernmental Agreement for Animal Control Services. Motion by Trustee Adams, second by Trustee Gonzales, to approve Intergovernmental Agreement with Rock Island County for Animal Control Services. Roll call as follows: White, McKay, Smice, Gonzalez and Adams: "Aye". Schneckloth absent. Motion approved.

Consideration and approval of Ordinance 2023-01, Amending Section 4.8.2 No Parking during Snow Removal. Motion by Trustee Gonzalez, second by Trustee McKay to approve the amendment to read "A) There shall be no parking upon any public way on any day when there has been snow accumulated to a depth of two (2) inches or more." Motion Approved by Voice Vote. Schneckloth absent.

Consideration and approval of the agreement with Mediacom Business Accounts for Hampton Fire, Village Administration and Heritage Center. Motion by Trustee White, second by Trustee McKay to approve the agreement and three (3) year pricing. Roll call as follows: White, McKay, Smice, Gonzalez and Adams: "Aye". Schneckloth absent.
