President Bornhoeft called the meeting to order at 6:30 PM. Clerk Reyes called the roll noting a quorum present and the Pledge of Allegiance was recited. Meeting was held at the Village Hall.

Consideration and Approval of the minutes from the meeting January 23, 2022. Motion by Trustee Adams, second by Trustee White. Motion approved by voice vote.

Consideration and approval of payment of Bills. Motion by Trustee Adams, second by Trustee Gonzalez to approve the bills. Discussion regarding a bill not approved from Police Department. Roll call as follows: White, McKay, Smice, Schneckloth, Gonzalez and Adams: "Aye". Motion approved.

**Acknowledgement of Visitors Who Desire to Address the Board.** Sean McKay addressed the board and would like a variance to an ordinance allowing for UTV to be driven and permitted in the Village of Hampton with the same restrictions already in place.

**Project Fund money.** Motion by Trustee McKay, second by Trustee Adams to approve the purchases. Trustee Adams would like all receipts of purchase. Roll call as follows: White, McKay, Smice, Schneckloth, Gonzalez and Adams: "Aye". Motion approved.

**Discussion regarding "Heart Boxes".** Clerk Reyes has some concerns regarding the heart boxes being installed as the original idea was not brought to the Board's attention. Chief Tone and Chief Johnson assured the board with the process of installing and keeping of information.

**Discussion regarding a plat of survey.** Building Inspector Tom Lupinski wanted to make the board aware of a plat that was recently combined with another lot. The lots in question are part of a previous issue in the village.

**Discussion regarding the New Employee Policy.** Trustee Adams made a motion to table, second by Trustee White. Motion passed by unanimous voice vote.

**Discussion, Consideration and Approval of the quote from gWorks regarding the municipal software changes.** Motion by Trustee McKay, second by Trustee White approved the software to begin in the new fiscal year May 1. Roll call as follows: White, McKay, Smice, Schneckloth, Gonzalez and Adams: "Aye".

Consideration and Approval of the quotes for a Public Works Dump Truck. Supervisor Toalson presented the board with quotes to replace the 18 year old dump truck. Motion made by Trustee White, second by Trustee Adams to approve the quote from McGrath. Roll call as follows: White, McKay, Smice, Schneckloth, Gonzalez and Adams: "Aye". Motion approved.

Consideration and Approval of the quote to replace damaged plow. The plow was damaged in the last snow fall. Motion made by Trustee Adams, second by Trustee White to approve the replacement plow using the rest of the funds from the ARP. Roll call as follows: White, McKay, Smice, Schneckloth, Gonzalez and Adams: "Aye". Motion approved.

Consideration and Approval of wage increase for officer. Chief Tone would like to give Sargent Patterson a raise to \$27.00 there was discussion regarding a supervisory status as a part-timer. Motion to give the raise by Trustee Gonzalez, second by Trustee Smice. Roll call as follows: Gonzalez, Smice and Schneckloth: "Aye" Adams, White and McKay: "Nay": tie vote President Bornhoeft: "Aye". Motion approved.

**Discussion, Consideration and Approval for Central Square software.** Motion to table by Trustee Adams, Second by Trustee White. Board had many questions for Chief Tone. Chief Tone will have a representative come talk with the board at the next meeting.
