**Consideration and Approval of an Ordinance of the Village of Hampton, Rock Island County, Illinois, amending Title 4 Community Protection; Article 4.4.2; Plant and Weed of the Code of Ordinances for the Village of Hampton, Rock Island County State of Illinois.** Motion made by Trustee White, second by Trustee Gonzalez to approve the amendment to redact the need to publish in the newspaper. Clerk Reyes stated it is very costly. Motion approved by roll call vote as follows: Adams, Gonzalez, Klouser, Johnson and White: "Aye". Smice absent. Motion carried.

**Consideration and Approval of the quote for keyless entry at the Heritage Center.** Motion made by Trustee Adams the quote from Global in the amount of \$3700.00, seconded by Trustee Klouser. **Parks and Heritage Center:** Trustee Gonzalez thank you for the approval and Hampton Days is fast approaching.


